## March 6, 2021 Member Minutes

The meeting was called to order by club president Roy Lawrenz at Article 15 Bar & Grill at 9:00 a.m. Fourteen members were present. Thank you, Article 15, for hosting our meeting!

**First Order of Business: Agenda** – A motion to approve the agenda was made by Jerry Frey and second by Adam Krause. Motion approved.

**Second Order of Business: Secretary Report/Minutes** – Anyone who received the 2/6/21 meeting minutes in hardcopy may have been missing page 2. A full copy of the 2/6/21 minutes is available on our website. A motion to approve the minutes was made by Jerry Frey and second by Bob Paasch. Motion approved.

**Third Order of Business: Treasurer Report** - Income and expenses were discussed. A motion to approve the report was made by Adam Krause and second by Tom Stadler. Motion approved.

**Fourth Order of Business: Old Business** – no old business

### **Fifth Order of Business: New Business**

1. Walker's Kraken Shack Trail – the club received a request from a private homeowner near Walker's Kraken Shack. The homeowner is asking if the trail coming off the lake can be re-routed, so it does not go past his home. The area in question is not part of the club trail and not something we are responsible; however, we are hoping to help solve the problem for the homeowner and keep access open to Walker's Kraken Shack. It was suggested to run a trail behind the gas station to Walker's Kraken Shack keeping business to the bar. Club members will look to see if this is possible.
2. DR Brush Cutter – the club looked at another brand of brush cutter. Club members will continue to research options and do a cost comparison. Brad offered to investigate the options for a new 20' trailer that will be needed to transport a new brush cutter. The club hopes to make a decision at the April 2021 meeting.
3. Letter to Landowners and Business Supporters regarding Coronavirus – Letters were sent to landowners and the local businesses that provided generous donations for the landowner appreciation dinner/fundraiser. Landowners and business supporters were made aware we are hoping to hold the landowner dinner in fall 2021 and that a donation of \$1000 was made to the Brazeau Ambulance Service.

4. Oconto County Snowmobile Alliance (OCSA) - OCSA will be holding an appreciation dinner on 3/20/21 for all groomer drivers however anyone is welcome. The dinner will be held at Tracys Place on Hwy 32 at 3:00 pm. If wanting to attend, please let them know as a headcount is needed.
5. Association of Wisconsin Snowmobile Clubs (AWSC) Report – AWSC membership ends April with a new membership year starting in June. The convention has been cancelled. Roy Lawrenz and Tom Stadler will participate in the AWSC officer elections. The 50/50 raffle will take place in fall 2021. County snowmobile trails are moving to a numbering system. We can begin using the numbers on trail markers starting next year however new maps will not reflect the change until the 2022-2023 snowmobile season.
6. Trail Reports – there was a decision to close the trails prior to the weekend due to the warm weather and deteriorating conditions.
7. Nominations of Officers and Directors with elections at our April meeting – nominations were made for club officers and directors. If a person is not elected as an officer, they do have the opportunity for one of three director positions. Nominations will be accepted until March 16. 2. Gift certificates will be sent to all landowners in April. Landowners will receive two \$10.00 gift certificates good at select local businesses. Approximately \$2000-3000 is spent annually on this initiative.
