## **September 11, 2021 BB Joyriders Club**

### **Member Minutes**

The meeting was called to order by club president Roy Lawrenz at the club storage shed at 9:00 a.m. Thirteen members were present.

#### **First Order of Business:**

Agenda – Using minutes from April 10, 2021, as agenda guide

#### **Second Order of Business:**

Secretary Report/Minutes – It was noted that Adam Krause email address was listed incorrectly in the printed copy of meeting minutes. A motion to approve the minutes was made by Jerry Frey and second by Chuck Panure. Motion approved

#### **Third Order of Business:**

Treasurer Report - Income and expenses were discussed. A motion to approve the report was made by Tom Yingling and second by Tom Stadler. Motion approved

#### **Fourth Order of Business: Old Business**

1. Walker's Kraken Shack Trail – There was discussion on moving the trail near the Kraken Shack. The Kraken Shack is up for sale. This is not a club trail so no say in any decision to re-route however would like to assist if possible. No decision currently

2. DR Brush Cutter - decision at 4/10/21, club meeting. Club is not purchasing a brush cutter

3. New trailer - trailer was purchased

#### **Fifth Order of Business: New Business**

1. Membership - Roy Lawrenz is transferring his duties as club membership manager to Adam Krause. To make this change official, AWSC requires this matter to be presented at a club meeting and voted on. A motion to approve the change was made by Jane Garrow and second by Tom Stadler. Motion approved. Currently 50 members have renewed via PayPal, 12 membership renewals have been received by USPS mail.

2. Polaris Ride Command Trail Manager - Roy Lawrenz presented correspondence from Adam Krause notifying the club that as the Polaris Ride Command Trail Manager for BB Joyriders, he has submitted an entry to win \$500.00. Thank you, Adam!

3. Trailer - Roy Lawrenz presented a request from Adam Krause to be reimbursed for mileage expenses he incurred when picking up the new club trailer. A motion to give Adam a \$50.00 gas gift card was made by Steve Garrow and second by Chuck Panure. Motion approved

4. AWSC Fall Workshop - Roy Lawrenz presented correspondence from Adam Krause requesting support/reimbursement for attending the upcoming AWSC Fall Workshop at an estimated cost of \$335.00. A motion to approve reimbursement was made by Jerry Frey and second by Brad VanHoff. Motion approved

5. Trail re-routing - Roy Lawrenz asked the club to consider re-routing the trail around Lee Lake Road due to more permanent residents moving on to this road. There was a suggestion to re-route the trail along the south side of the lake. There was discussion on potential options and challenges to make this happen. No decision was made.

6. Trail Reports - a. Trail to Coleman Swamp needs modification with a possible bridge b. The County is considering changes to the south end of the pipeline c. The club needs information and permission from the new landowners near Lee Lake to Round lake d. Trail near W may need to be straightened and the stumps pulled from this section of trail e. Lots of brushing is needed throughout the trail system 7. Insurance for landowners - the club has received the bill and needs to submit payment for our (approximately 89) landowners. Bill is due in October. A thank you note and a copy of the insurance policy will be sent to each landowner. There was discussion on what information is needed from landowners and that a new uniform document to be used for landowners may be coming 8. Signs - the County will be ordering new signs. Trail Managers should let Tom Stadler know of any new signs that are needed. We are going away from orange arrows and moving to yellow arrows 9. Landowner Appreciation Dinner - the dinner has been rescheduled again for April 2022 10. Trailer insurance - there was discussion on the need to purchase insurance for the new club trailer. A motion to purchase insurance was made by Brad VanHoff and second by Steve Garrow. Motion approved 11. Old club trailer - Tom Stadler indicated he will try to sell the old club trailer. A motion to sell the old club trailer was made by Jane Garrow and second by Cheryl Paasch. Motion approved 12. Trail Boss retirement - Jerry Frey is retiring as a Trail Boss and a new trail boss is needed. Tom Stadler will ask an existing club member if he will consider taking over this responsibility. Adjournment - a motion to adjourn the meeting was made by Jerry Frey and second by Jane Garrow. Meeting adjourned
